Don Keavany from the law firm of Christopher, Hays, Wojcik & Mavricos in Worcester representing the Laramée's in this matter. What they are seeking is a special permit pursuant to 3.43 of the Douglas bylaws for relief to reconstruct that pre-existing non-conforming gazebo into what is there today, with proposing to move it over five feet of the lot line in the revised plot plan dated January 31, 2022. The Chair stated he would like to see the gazebo moved further away from the lot line than what is being proposed. Mr. Bombara stated that he agrees with the Chair and would like to see it 12 feet away from the lot line. Mr. Forget disagrees and his opinion is that he is satisfied with the plan submitted. The concerns from the board about this is the distance from the leaching site and the lot line. Attorney Keavany asked the board for a continuance to work through the septic issue and the lot line issue and come to some agreement. Mr. Hathaway (18 Hough Rd) and Ms. Wilson (11 Hough Rd) stood up and told the board that they are in favor of the Laramée's new structure. Attorney Keavany and Ms. Laramée stepped out of the room to have a quick discussion.

(7:55 PM) (54:42) Board passed around a voucher to sign.

(8:04 PM) (1:03:04) Attorney Keavany and Ms. Laramée joined the meeting again.

Attorney Keavany asked the board if the structure gets moved 12 feet away from the Snow lot line with the current dimensions of the structure will the board approve the building permit. Ken Frasier the building inspector responded that he would need to see something more about the septic system to make that determination, and Mr. Fitzpatrick stated that you must be a minimum of 10 feet away from the septic and if you are less than that then you must go to the board of health to get a waiver.
