

Matt Bellisle with Pare Corporation along with colleague Lauren Gluck joined remotely to present slides for the plan and new changes. This is a renewal of the existing plan that was first drafted and approved in 2011. The updates and changes include:

- Clarifying that the stone masonry maintenance includes above and below water activity
- The vegetation maintenance between the culvert spillway and the right abutment
- Vegetation maintenance at the saddle dyke will be continuing
- Updated to include the current officers on the board for contact information
- Clarify that the causeway inspection and maintenance is not part of the district's requirements because it is a town owned structure


