**Old Business:**

1. (7:03 PM) (0:55) (NOI-DEP #143-1024) Public Hearing Continued: Notice of Intent: Shore Road Lot 299 Parcel 7.16 – Cliff Van Reed – Possible Votes

Margaret Bacon with Civil Site Engineering joined remotely and would like to ask for a continuance.



Rob Lussier with CMG at meeting to present plans. They addressed the peer review comments and resubmitted after the last meeting and received a response from McCarty Engineering to our peer review comments. Mr. Lussier will update the commission of the riverfront analysis the alternatives analysis, they added more information and was more descriptive. They looked at other properties in Douglas and explained why this location is the most feasible option for the project. Regarding the peer review comments and all items were addressed and there is one item that the comment has some concern which was the 8.27 inches per hour rate. When the soil was tested it was agreed that it was sand, but on the soil logs it was listed as loamy sand which Mr. Lussier believes is a typo. Mr. Lussier is going to get confirmation from all who where present at the site at the time of soil testing for confirmation. Mr. Lussier will send DEP a complete revised edited version with the corrected soil testing documentation. One other issue that wasn't included was the fee calculation for the wetlands buffer zone which Mr. Lussier will take care of.

Mrs. Snow stated that they would like to replace their current dock that is falling apart with a new one that is 10 feet longer for a total of 42 feet long and two additional 8 footers on the side. The commission is looking for any additional impacts and how its going to be installed. Applicants are removing posts to old dock and the new one will just sit on top of the ground. The new dock will be 4 feet by 42 feet and the one going off the left side is 8 feet by 8 feet (232 square feet).
