Chair Dan Heney called meeting order at 7:05 PM

1. **(7:05 PM) (0:13) Public Hearing: Michael Crosier (#2022-02) 16 Brookside Dr.**
Date of Application: 3/8/2022
Decision Date for Variance: 100 Days of Application (6/16/2022)
Mr. Crosier is seeking a variance of 10 feet for setback relief under dimensional regulations appendix b to build a deck in a VR zone district. All the certified mailings have been returned. The board requests that the applicants provide a certified plot plan done by a surveyor for the record in order to make a decision on this variance. Applicant is requesting a continuance in order to get the distance of the deck and back lot line surveyed.

Date of Application: 2/9/2022
Decision Date for Special Permit: 90 days after close of public hearing plus an additional 30 days per the Zoning Board.
Donald Keavany with Christopher, Hays, Wojcik & Mavricos in attendance on behalf of applicants and presented the revised plan proposal for the cabana. The board would like to see the 10 feet from the property lines instead of the 8.2 feet presented on the current plans. Mr. Keavany asked for a 2-minute break to discuss the 10 feet change with the Laramée's.

Mr. Keavany and his clients (Laramée's) are agreeable to amend the plan to have the proposed cabana Sona tubes be 10 feet or more from the boundary lines and from septic tank with the 13-inch overhang. Board clarifies that no portion of the structure will be closer than 9 feet, with the conditions of a revised plan and no enclosing of the side walls of the structure and all necessary permits to be taken prior to construction and no structure or overhang should encroach between the cabana and the lot line at any point.

Mr. Minarik recommended that the applicant build a bridge across the Mumford River to access Gilboa Street to keep all truck traffic off the local streets. The town will retain ownership of the parking lot, Gilboa pond and the dam with this project. The Board's comments are concerns about the lighting and the possible noise.

Ken Frasier's updated that he spoke to Neil Rybicki on Tuesday and requested a full schedule on the proposed finishing up of phase one and two, and as soon as he receives the schedule, he will distribute it to the Board. They are hoping to finish foundation work on Nautical Way to Center Road, and proposal for the last loop of the road they want to get started on before the end of this year. The board requests to keep up to date on the sale of the affordable units.
