Mitch Cohen called the meeting to order at 7:03pm

1. **FY15 Re-organization:** Tom nominated Mitch Cohen for Chair, Bob 2nd, unanimous favor. Bob nominated Tom Devlin for Vice Chair, Chris 2nd, unanimous favor.
2. **Financials:** Thru 6/14: F/T Wages: YTD: \$7,218.68, P/T Wages: YTD: \$21,243.15, Repairs and Maintenance: YTD: \$434.44, Advertising: YTD: \$117.90, Legal: YTD: \$7,745.00, Engineering/Architecture: YTD: \$337.50, Office Supplies: YTD: \$891.11, Other Supplies: YTD: \$49.98, In-state Travel: YTD: \$160.40, Dues and Membership: YTD: 600.00, Equipment: YTD: \$2,447.50. Total YTD: \$41,245.66. Pat went through End of FY14 spreadsheet.
3. **Correspondence:** Charter sample bill, Open Meeting Checklist, Bob and Tom reappointment letters, Comcast/Charter transfer notices. Mitch explained the ComCast takeover of Central MA from Charter. He spoke to Atty Solomon and Tom Cohan of Charter and both said the newly signed license will transfer as-is to Comcast. The Town has a right to an open hearing about the matter to discuss possible issues, but Atty Solomon said that would be unnecessary, as Comcast can clearly maintain service appropriately to Douglas and abide by the current contract. Mitch will pass the recommendation to *not hold a public hearing* on to the Board of Selectmen, as they have this issue listed on their Agenda.
4. **FY16 Revenue:** The Board of Selectmen approved the FY16 revenue request of a 3% increase, to be received in March 2015. A discussion about the fiber lines to be installed in accordance with the new license, how they will be laid out at the Municipal Center, and any new equipment that is to be installed.
5. **Meeting Minutes:** 5/12/14: Tom motioned to accept as presented, Bob 2nd, unanimous favor.
6. **Job Description "Cable Coordinator":** The Coordinator position was changed from part time to full time, and the Personnel Board wanted the DCAC to take another look at the current job description. Tom motioned to approve the Cable Coordinator job description as written with one change from "Part time" to "Full time", Bob 2nd, unanimous favor. Mitch will forward to the Personnel Board.
7. **Cable Coordinator Benefits:** Pat explained a sheet from Jeanne explaining the

calculations of the new benefits attached to the full time Coordinator position, including how she calculates sick, vacation, and personal days. Pat also submitted a memo to the Town describing his wish to surrender all holidays except for the "big four" holidays: New Years, July 4th, Thanksgiving, and Christmas - in order to have optimal flexibility. Tom motioned to appoint Mitch Cohen to sign off on the presented time off and holiday provisions for Cable Coordinator "full time" benefits as presented, Chris 2nd, unanimous favor.

8. **Coordinator Review:** Placed on the Agenda for next meeting.
9. **Coordinator's Report:** Pat submitted May & June 2014 meetings report. Pat acknowledged that he needs to go back through and take out "public" events from the meeting report and create a Public sheet as well. Douglas Cable Access has been "Google Verified" in business listings. Memorial Day 2014 video was good, stickypod was great, shotgun mics worked well. Video is on YouTube and Channel 11. YouTube archive has been completely transferred to the new YouTube account: <http://www.youtube.com/DouglasCableAccess>. New programs: Skin Talk was submitted, KidMissing episode 6 is on YouTube and broadcast, Douglas Farmer's Market opening day video on YouTube and broadcast. Digital Video Training Summer 2014 has begun, students in production phase. Judged a video contest for ACM-NE, Video festival is in NH October 9-11, 2014. Pat visited the High School Room 208 to audit their equipment, will have some equipment recommendations. Pat submitted some equipment research for "field" production, and will narrow it down further. Some discussion about equipment needs.
10. **Equipment:** Bob motioned to spend up to \$300.00 for an EZ-Up tent, a folding table, and a couple folding chairs, Tom 2nd, unanimous favor.
11. **Other Business:** Need more space on GoogleDrive. Pat will email John Ducharme.
12. **Adjourn:** Bob motioned to adjourn at 8:07pm, Chris 2nd, unanimous favor.

Re: Charter Communications/Comcast Corporation Transaction

Dear Mr. Guzinski:

As you may have read, Charter Communications, Inc. ("Charter"), the ultimate parent of the entity holding the cable franchise in your community, has entered into an agreement with Comcast Corporation ("Comcast"). Pursuant to this agreement, Comcast will become the ultimate owner of your franchisee.

As a preliminary matter, Charter will undertake certain pro forma internal restructurings, and your cable franchisee will become CCO Transfers, LLC, (still remaining entirely under the ownership and control of Charter). Immediately thereafter, your cable franchisee will become an indirect, wholly-owned subsidiary of Comcast.

If you determine that your consent is **not** required for this transaction to proceed, you need not take any further action. If, however, you believe your consent is necessary, we have provided copies of the Federal Communications Commission's ("FCC") Form 394, other information, and a draft consent resolution to help facilitate the consent process.

- **FCC Form 394.** FCC Form 394 (required copies enclosed) is designed to provide you with the relevant information needed to assess the financial, legal, and technical qualifications of Comcast to be the ultimate parent entity of your cable franchisee.
- **Timing.** According to the FCC's rules, if you decide consent is required, you have a maximum of 120 days from the date you receive this information to review all materials and act upon our request for consent to the transaction. (Please note, your franchise may specify a shorter time frame.)
- **Consent Resolution.** Should you choose to affirmatively consent to the transaction, we have enclosed a draft consent resolution to be used to help expedite the consent process. We would request that a consent resolution, if needed, be placed on your agenda for consideration at your earliest convenience.

All of us at Comcast are excited about the opportunity to serve your community. 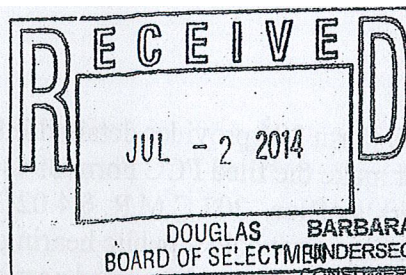

TRANSFER BULLETIN

June 27, 2014

On April 28, 2014, Comcast Corporation ("Comcast") announced, as part of a broader transaction, that it will become the ultimate owner of all of the Massachusetts cable licenses currently held by subsidiaries of Charter Communications, Inc. ("Charter"). More specifically, control of the cable license holder in each Massachusetts community will transfer from other Charter subsidiaries to CCO Transfers, LLC, which in turn will become an indirect, wholly-owned subsidiary of Comcast. Charter (Transferor) and Comcast (Transferee) seek approval of this transfer at this time.

To that end, on or about June 18, 2014, the issuing authority in each of the 53 Massachusetts communities currently served by Charter should have received a Federal Communications Commission (FCC) Form 394, Application for Franchise Authority Consent to Assignment or Transfer of Control of Cable Television Franchise ("FCC Form 394" or "Transfer Application") for the transaction. By this Bulletin, the Competition Division of the Massachusetts Department of Telecommunications and Cable (DTC) informs the affected communities of the transfer process and public hearing requirements.

The transfer process began when each community received the FCC Form 394s, in this case, on or about June 18, 2014. It is important to note the date of receipt of the FCC Form 394 by each community, as this Receipt Date triggers a 120-day review period during which the issuing authority must comply with certain deadlines. 47 C.F.R. § 76.502; 207 C.M.R. §§ 4.01-4.06. First, the issuing authority must notify the cable operators within thirty (30) days of the Receipt Date of any questions regarding the accuracy of the FCC Form 394 and accompanying information. 47 C.F.R. § 76.502. Second, the issuing authority must hold a public hearing during the first sixty (60) days after the Receipt Date. 207 C.M.R. § 4.03. Finally, the issuing authority must decide whether to accept or reject the transfer within 120 days of the Receipt Date. 47 U.S.C. § 537; 207 C.M.R. § 4.02. Please note that if an issuing authority does not take action on the application within the time frames established by federal and state law, the application is deemed approved. 47 U.S.C. § 537.

To further clarify the time frames as set forth above, federal regulations require that an issuing authority notify the cable operators within thirty (30) days if it determines that the Transfer Application and accompanying information is inaccurate. 47 C.F.R. § 76.502. Absent notification to the cable operators within the thirty (30) day window, the information is deemed to be accurate and sufficient as filed to render a decision on the transfer proposal. *Id.*


The FCC Form 394 provides detailed information on the proposed transfer. Issuing authorities must make the filed FCC Form 394s available for review by interested parties at the city or town clerk's office. 207 C.M.R. § 4.02(1). Within sixty (60) days of the Receipt Date, the issuing authority must hold a public hearing in order to insure that the Transferor and Transferee, residents, and other interested parties are afforded full and fair opportunity to comment on the proposed transfer. *Id.* § 4.03. State law requires that a decision on the transfer be made only after a public hearing. G. L. c. 166A, § 7; 207 C.M.R. § 4.03. Issuing authorities are responsible for conducting the hearing as well as providing the hearing location and notice of the hearing. 207 C.M.R. § 4.03.

To comply with state regulations, each issuing authority must arrange for notice of the hearing to be published in a newspaper of general circulation in the affected city or town in each of two successive weeks, the first publication being not less than 14 days before the day of any such hearing. 207 C.M.R. § 2.02. Where a community has a cablecasting facility within the control of the cable operator, the cable operator must also provide notice to the community by cablecast at least twice a week, on separate days, during each of the two weeks prior to the hearing. *Id.*

Following the hearing but within 120 days of the Receipt Date, each issuing authority must determine the appropriateness of the transfer and render a final decision to the cable operators. 47 U.S.C. § 537. As stated above, if an issuing authority fails to render a final decision on the transfer within 120 days, the application is deemed granted. *Id.* In determining the appropriateness of the transfer, Massachusetts law states that "[n]o license or control thereof shall be transferred or assigned without the prior written consent of the issuing authority, which consent shall not be arbitrarily or unreasonably withheld." G. L. c. 166A, § 7. In order to ensure that a determination is reasonable, issuing authorities may consider only the Transferee's (a) management experience, (b) technical expertise, (c) financial capability, and (d) legal ability to operate a cable system under the existing license. 207 C.M.R. § 4.04(1); *In the Matter of MediaOne of Mass., Inc. v. Bd. of Selectman of N. Andover*, CTV 99-2, 99-3, 99-4, 99-5, *Order of Motions for Summary Decision/Consolidation* (May 1, 2000). In addition, issuing authorities may not "propose amendments to or renegotiate the terms of the existing license or any license renewal proposal." 207 C.M.R. § 4.04(2).

Re: FY16 Cable Operating Budget

Note: This memo is similar to that distributed in advance of the May 6th Board of Selectmen meeting. The only substantive change is indicating that the Cable Committee has unanimously voted to recommend the Board of Selectmen set the FY16 operating budget (March 2015 Charter payment) at \$48,448. The prior memo indicated this was a recommendation from the Chair pending discussion and vote, which has since occurred. I've also added comparisons to the FY16 payment already approved in the license, and per-subscriber cost calculations.

I have been informed that the Board of Selectmen will be discussing the FY16 Cable Operating Budget on May 20, 2014.

The operating budget, or more specific to your discussions the license fee payment made by Charter as the revenue source for the operating budget, has been consistent since its creation in 2003. Each year has been funded at 3% greater than the prior year. The Board of Selectmen continued this practice for our FY15 operating budget when approving the new license this past September.

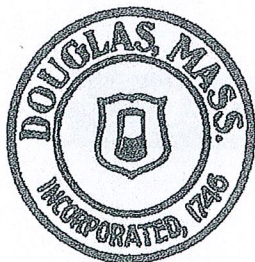
As you are aware, the Cable Committee has interest in expanding our services. We are very aware the Board of Selectmen has not supported this expansion, therefore we are not requesting funds to support a service expansion at this time.

Our Cable Coordinator and six Cable Recording Assistants are on the town's standard compensation plan. While the FY16 plan has not yet been drafted, the FY15 plan shows a 2.25% step increase and a 1.00% COLA for employees. At this time we are simply interested in funding this adjustment.

Our FY15 operating budget (and previously-received Charter payment) is \$47,037. The license approved late last year provides a FY16 operating budget payment of \$100,630. The Cable Committee has voted unanimously to continue past practice and increase again by only 3%, for a Charter payment of \$48,448.

This change will increase cable bills by 4.9 cents per month on a typical \$80/month bill, or 58 cents per year on a typical \$960/year bill, or a 0.061% net increase.

(b) The Licensee shall provide payments to the Town or its designee to be used to support ongoing operations of PEG Access operations and programming (the "PEG Access Support"). Such payment shall be used by the Town or its designee for personnel, operating and other related expenses incurred in connection with PEG access programming and/or operations. Subject to the limitation in Section 9.1(b), the PEG Access Support provided by Licensee shall be as follows: Year One of the Renewal License term, Licensee shall pay Forty-Seven Thousand Thirty-Seven Dollars (\$47,037). Thereafter, the Licensee shall pay the following dollar amounts, or such lower dollar amounts that the Issuing Authority shall notify the Licensee of in writing no later than one hundred twenty (120) days prior to the annual anniversary date of this Renewal License: Year Two of the Renewal License term: One Hundred Thousand Six Hundred Thirty Dollars (\$100,630); Year Three of the Renewal License term: One Hundred Sixteen Thousand Thirty-Nine Dollars (\$116,039); and beginning with Year Four of the Renewal License said dollar amount of PEG Access Support shall increase three percent (3%) each year (i.e. Year Four of the Renewal License: One Hundred Nineteen Thousand Five Hundred Twenty Dollars (\$119,520), subject to the above referenced right of the Issuing Authority to provide one hundred twenty (120) days' notice of a lower dollar amount of PEG Access Support as the Issuing Authority may determine. PEG Access Support payments shall be made no later than March 31st following the anniversary date of the Renewal License. All such PEG Access Support payments to the Town shall be placed by the Town in a special PEG Access account, and not into the Town's general fund. If requested in writing by the Issuing Authority, any such payment shall be accompanied by a general statement of the total amount of Gross Revenues which shall also provide in reasonable detail the general categories comprising Gross Revenues as defined in Section 1.1(11) above and the revenue attributable thereto. The Licensee may externalize, line-item and/or pass-through this PEG Access Support on to Subscribers to the extent allowed by applicable law and regulations.

(c) In the event that the PEG Access Capital Funding (Section 8.3(a) above) or the PEG Access Support (Section 8.3(b) above) is not paid on or before the due dates set forth in this Renewal License for such payments, then interest shall accrue from the due date until the date paid at the rate equal to two percent (2%) above the prime rate at the at the Federal Reserve Bank of Boston or its successor.

(d) The Issuing Authority or its designee shall upon written request of the Licensee prepare an annual report for the preceding calendar year which records how the annual payment for PEG operations was spent, and what amount remained unspent at the end of the calendar year. This report shall be submitted to the Licensee within thirty (30) days of said written request.

2. Approve-New Class II License-K-2 Automotive (04:55)

In the packet is a new Class II application.

Ms. Kane presented the application. The business was sold and purchased by the Morgans. Ms. Kane received comments from all the other committees. They will retain the conditions of the last license, which include a six vehicle limit, standard required Fire Code Compliance policy, \$25,000 bond, etc. Mr. & Mrs. Morgan joined the meeting. The Morgans do not have any plans to expand past six vehicles.

Mr. Davis made a motion to approve the Class II License for K-2 Automotive as presented. Mr. Brown seconded the motion. All-Aye.

3. Cable PEG Access Fees Discussion (24:14)

In the packet is a memo from Mitch Cohen dated May 14, 2014.

Mr. Cohen joined the meeting to speak about the FY16 Cable budget. They are requesting \$48,448, which is a 3% increase over the FY15 revenue to cover COLA and steps. Mr. Cohen explained the background behind the request and the Cable license requirements. A discussion was held, including the revolving fund, Capital plans, 501c(3) programming, wages and fees.

Mr. Cohen announced events that are planned and the availability of free classes in television production for Town residents. Audio quality for the School Committee meetings and in the Resource Room was discussed.

Mr. Davis made a motion to approve the Cable Commission's request as presented. Mr. Brown seconded the motion. Vote: Aye-4, No-1.

4. Old Grammar School Disposition Committee (OGSDC) Request (50:39)

In the packet are a memo from Mr. Cundiff dated May 14, 2014, a memo from Jay Talerman dated March 19, 2014, and a sketch of a concept plan.

Mr. Cundiff joined the meeting and presented that the Town voted at the last annual Town Meeting to change the zoning in the area of the Old Grammar School at Gleason Court. The OGSDC recommends proceeding with laying out Gleason Court as a public way. The School Committee would rather have a public way as opposed to reserving an easement. There would be no change in the Town's responsibility for the road. There will be a cost associated with this. The next Annual Town meeting is the soonest that this could be laid out. A discussion was held. The BOS was supportive, contingent upon the cost. Mr. Cundiff will reach out to the property owner, gather responses and come back to the BOS with cost estimates.

5. Reconvene Strategic Budget Committee (58:50)

Mr. Guzinski summarized the events discussed at the last meeting. Mr. Guzinski will draw up a draft for a five-member board to financially plan out the next five years for the Town, including a set of goals. The BOS was supportive of reconvening the Strategic Budget Committee to look at how to proceed within the cap.

Mr. Guzinski will prepare a draft of the scope and goals of the Strategic Budget Committee for the next meeting.

Re: Paid Holiday Agreement for Cable Coordinator

As you know, in March of 2014, the Douglas Cable Advisory Committee (DCAC) increased the hours for the Cable Coordinator position from (19) hours per week to (29) hours per week. This change has benefits including sick time, vacation, personal days, and paid holidays.

The Personnel Bylaw lists a total of (11.5) holidays, the majority of which occur on a Monday. The DCAC has considered making Monday a mandatory day off to help mitigate this benefit, but I value Monday as a workday, and would prefer not to have it cut from my schedule.

In order to ensure the flexibility that this position requires, and to allow me to work on Mondays, I would propose that I only be compensated for what I consider to be the "big four" holidays of the calendar year:

- New Year's
- July 4th
- Thanksgiving
- Christmas

This will free up my scheduling needs so that I can maintain optimum flexibility to work any day during the week without worrying about the holiday schedule. I feel that this is a mutually fair agreement and I appreciate the Town's consideration on this matter. I would also like to be able to re-open this discussion in the event that my hours are changed in the future.
