Re: Request for MOU

As previously discussed, we would request that an MOU is created adding the following language to our current contract, adding each paragraph to the end of each designated section. This is a language change providing more specific descriptions.

32.11 Examples of Town Details include; security assignments and/or traffic control for School and Douglas community related functions such as; sports events, school dances, graduation ceremonies, Octoberfest, parades, the lighting of the Town Common etc. Other examples include security and/or traffic control for jobs completed by Town Municipalities such as Highway Department and Water/Sewer Department staff. (Not to include work completed by outside vendors/sub-contractors). Examples of applicable Town Detail work includes; water main breaks, water testing, pothole repairs, bridge repairs, tree removal etc., all of which are completed by Town of Douglas Municipal Employees.

32.17 A vendor is required pay the minimum amount relative to the hours requested regardless of actual hours worked by the Officer and as described in section 32.12 of the Douglas Police Union Contract.

As examples, A vendor requests a detail scheduled to last 6 hours, the vendor is required to pay the contractual 8 hour minimum as requested regardless of the actual worked hours. Similarly, a detail is
