Mark Mungeam called the meeting to order at 6:33 pm.

(0:45 TS) Meeting Minutes: May 19, 2025 – Possible votes
Deferred to the end of the meeting.

1. (1:00 TS) 6:30 PM (RDA) Public Meeting: Request for Determination of Applicability, Andrew Paine, 173 West Street, (Septic Repair) Map 145 Lot 31 – Possible votes
Margaret Bacon with Civil Site Engineering representing Andrew Paine and presented the plans to the commission for the proposed septic repair, and this has been approved by the Board of Health. Sam Carew showed photos of the site and where the proposed septic will go, Brandon Faneuf the Conservation Agent and her do not have any concerns with this and the leech field is outside of the 50-foot buffer zone, and they recommend a negative determination.
Josiah Burch recused himself, as he is the applicant's neighbor.
(11:20 TS) Motion for a negative determination of applicability for 173 West Street, (Septic Repair) Map 145 Lot 31, made by Jim Foran, 2nd by Brendan Doyle. Roll call vote – Jim Foran, Brendan Doyle, Kate Thompson, Mike Greco, Mark Mungeam all in favor.
2. (13:00 TS) 6:30 PM (RDA) Public Meeting: Request for Determination of Applicability, Cynthia Prockette, 44 Ridge Trail, (Septic Repair) Map 131 Lot 17 – Possible votes
Margaret Bacon with Civil Site Engineering representing Cynthia Prockette and presented the plans for the septic repair and went over the details of the project and has already been approved by the Board of Health. Sam Carew showed photos of the site, found no issues with this, and recommended a negative determination.
(19:55 TS) Motion for a negative determination of applicability for 44 Ridge Trail, (Septic Repair) Map 131 Lot 17 with the condition there be no stock piling on the property, made by Jim Foran, 2nd by Mike Greco. Roll call vote – Jim Foran, Brendan Doyle, Mike Greco, Josiah Burch, Mark Mungeam all in favor.
3. (22:00 TS) 6:30 PM (RDA) Public Meeting: Request for Determination of Applicability, Aaron Socrat, 49 Lindbergh Ave, (Addition) May 227 Lot 20 – Possible votes
Aaron Socrat spoke about his proposed addition and went over the details of the project. Sam Carew showed photos of the site and where the addition is proposed and where the hot tub is proposed to be put, and the only comment she had is that the addition is going to be within the 50 foot no build zone, but it is previously disturbed. It is up to Mr. Socrat to explain to the commission why he believed there would be no adverse impacts to resource areas by building this within the 50-foot no-build zone. Mr. Socrat explained that it is all within existing lawn, and Ms. Carew stated that she would recommend a negative determination.

7. (57:00 TS) Request for Certificate of Compliance (DEP #143-1079), Norma Aldrich, 58 Cottage Colony, Map 159 Lot 34 – Possible votes
Margaret Bacon with Civil Site Engineering representing Norma Aldrich reviewed the plans, and Sam Carew showed site photos, went over the details, and said the erosions can come out. The commission would like to see the listed out changes that were made as shown on the as built in the letter. Margaret Bacon will update the letter and the plan and come back to get approval when that is completed.

Robert Cherrier with Lackey Dam Properties joined remotely, Sam Carew showed site photos of the grass grown in, and she recommended maybe adding some more seed for the grass and remove the erosion controls.

The applicants are going to fix the items suggested with the grass and the sediment build up and come back to get a full certificate of compliance.
